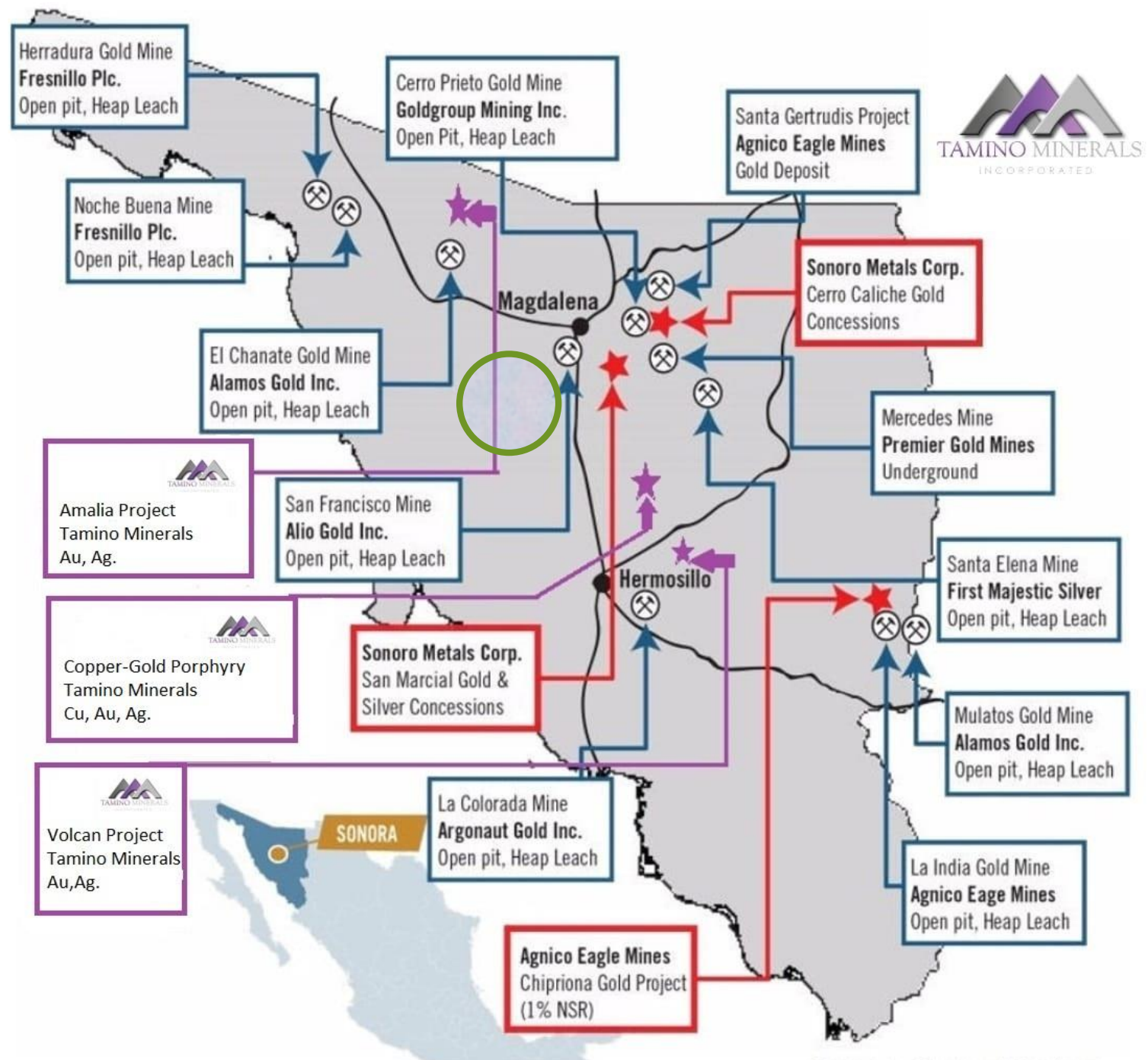

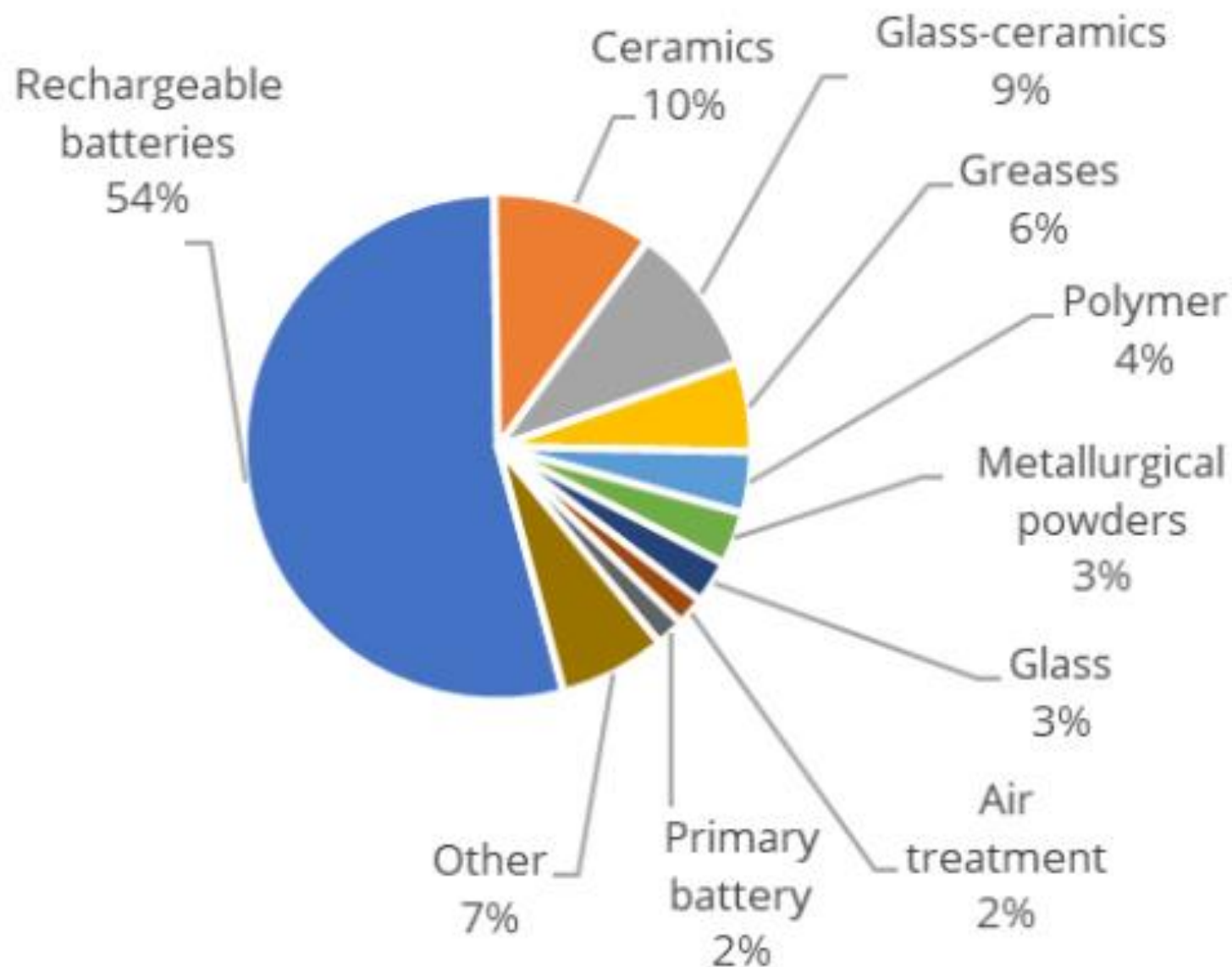


# Tamino Minerals, Inc. Projects – Lithium in a Circle





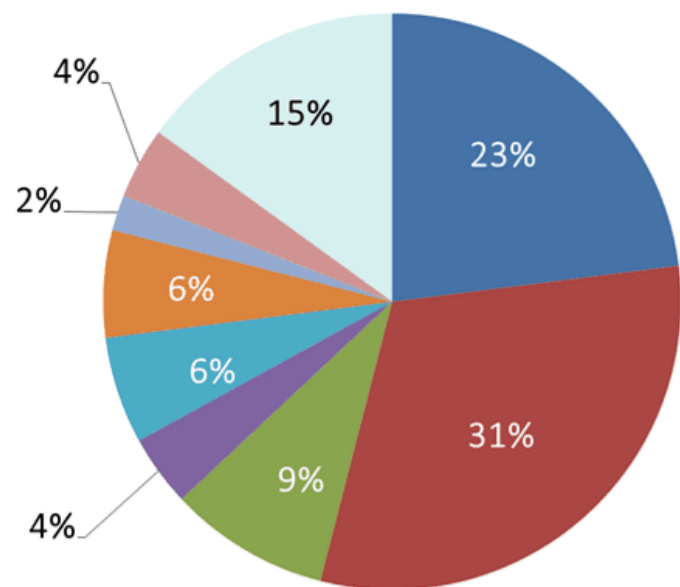
# Tamino Minerals, Inc. Projects – Lithium Uses



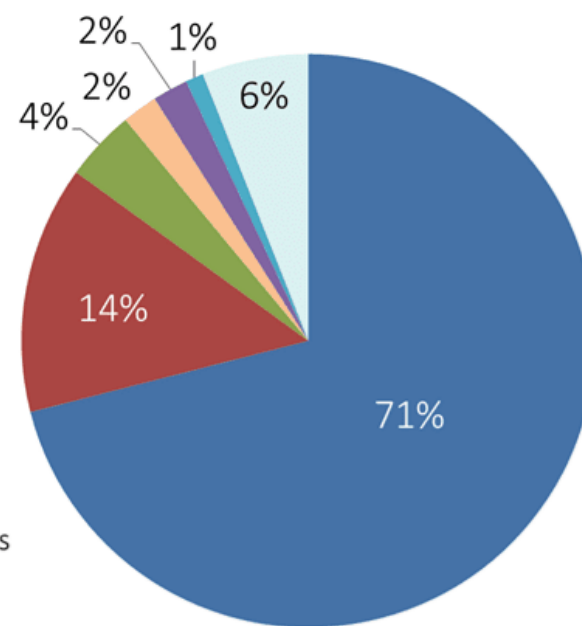
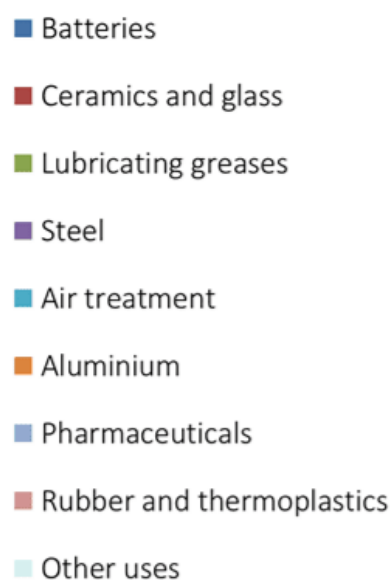
# Tamino Minerals, Inc. – Evolution of Lithium Utilization



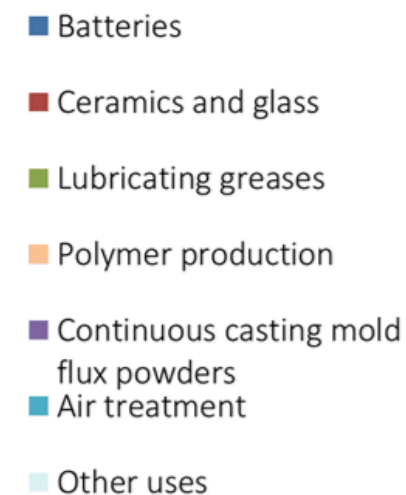

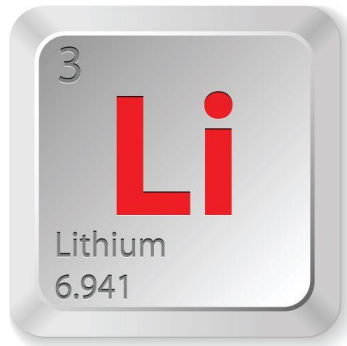

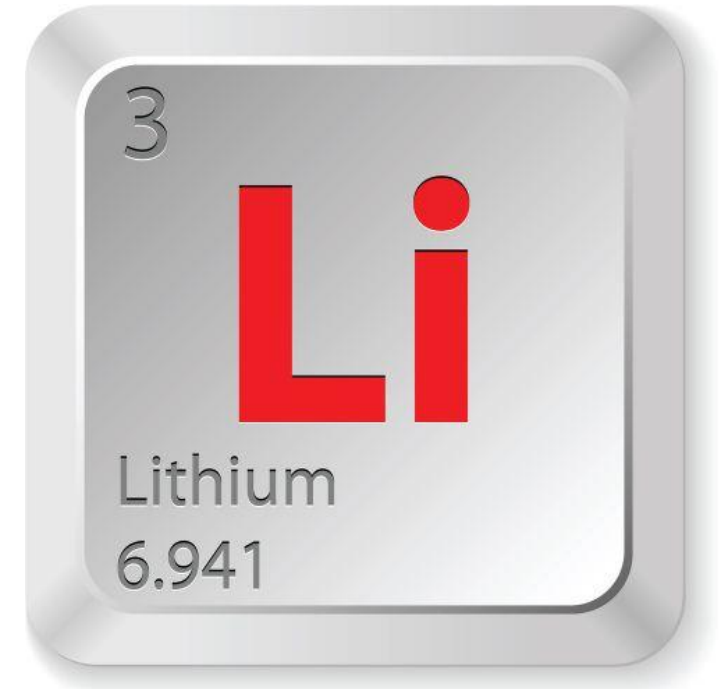
